### IMPORTANT TAX INFORMATION

In 2013 the Women's Club at UCF, Inc. incorporated as a 501(c)(6) organization, which is a business league. The revenues of our organization are historically less than \$25,000 per year and do not warrant the club operating as a charity under 501(c)(3) rules. Additionally, there are significant accounting requirements for a charity under IRS rules, which would be onerous for a completely volunteer Board or costly for the Board to hire accounting expertise.

Under IRS rules, contributions to a 501(c)(6) organization such as ours are NOT deductible as charitable contributions on an individual donor's federal income tax return. The Women's Club at UCF, Inc. is not permitted to issue receipts for a charitable contribution, either for cash or tangible goods (e.g. clothing, auction items).

If you wish to make a monetary donation towards our scholarships and also claim a charitable deduction, please make your check payable to the UCF Foundation and indicate "Women's Club at UCF – scholarships" on the memo line. This will ensure that your donation benefits our organization's scholarship funds. The UCF Foundation is a charitable organization and can issue receipts for tax purposes.


## ANNUAL COOKIE EXCHANGE
