An outstanding program was presented by **Kay Rawlins**, Founder of the Orlando City Soccer Club and President of Orlando City Foundation. She shared the mission of the foundation which is:

“.. to use the sport of soccer to promote a healthy lifestyle that enables children and families to reach their full potential. We accomplish this by providing soccer programming, nutrition education, mentoring, and by making strategic community investments in the neediest areas of our community.”

She outlined some of the community outreach initiatives of the Orlando City Soccer Club which include programs and campaigns that focus on cancer research and treatment, anti-discrimination, community service, health and wellness, environmental sustainability, and accessibility to soccer.

The Orlando City Foundation, a certified 501(c)3 nonprofit organization was established to facilitate these charitable programs, projects, and initiatives, as well as philanthropic investments. They provide free soccer programming, investing in safe places to play, and focusing on urban gardens and access to healthy food choices. A partnership with the Paramore community has been established and they seek to make a difference in children's lives. Truly, these two organizations exemplify community engagement.
