Member response has been approximately 33% and \$8000 has been raised. Somerville Endowed Graduate Scholarship balance \$201,302.00 Somerville Graduate Scholarship Spendable \$9,370.57 Two Graduate Awards for \$3,000 to be given 2018-2019 - (have been awarded)

Undergraduate Endowed- \$186,167.03 Undergraduate Spendable- \$18,122.37 (Three awards at \$3,000 for 2018-2019 have not yet been dispersed)

M. LeClair recommended for the year 2019-2020, the Women's Club award 2 Graduate scholarships of \$3000 each and 3 Undergraduate scholarships of \$3000 each. Motion made and seconded; motion passed.

Website: T. Riedel reported that the interest groups and membership list has been updated on the website. Z. Hashem is working with the technical support person to get interest group dates uploaded.

Sunshine: Appropriate greeting cards have been sent to members.

Newsletter: R. Rieder announced the next newsletter will be sent out near the end of January. Items for inclusion should be submitted by Jan 1, 2019. Kudos were given to T. Riedel, M. LeClaire and Z. Hashem for the excellent newsletter published in September.

Interest Groups: J. Simonet is working with Interest Group leaders to coordinate dates so that there are not conflicts with other groups or with board meetings. It was also reported that some events have a monetary charge.

OLD BUSINESS:

At the October meeting, the board reviewed the potential to make a donation to one of the UCF Student Emergency Funds used for students in need. The board expressed interest in donating \$500 to one of these programs. K. Weise will research any possible issues with legal counsel. This type donation should be discussed at three consecutive board meetings before implementing.
